A YEAR IN REVIEW - DECEMBER 2012 TO DECEMBER 2013

2014 PLANNING

2014 will bring a move from development/planning to creating deliverables. The BBBHC Survey recently sent out to members was the first step in this process. During the meeting, members were asked to provide input about which components of the BBBHC should "start", "stop" or "continue". This included monthly coalition meetings, as well as current and new focus areas. After sharing input individually, members met in small groups to discuss ideas to focus efforts on in 2014. Each table then shared their ideas with the whole group.

Group Ideas Shared:

Consumers / Patients

- Education for patients / community
- Educate public on advanced directives
- Speaker's Bureau

- Caregiver Tool What is the care recipient at risk for? App? What can I do to keep loved one safe?
- Transportation how to get information to patient
- Post-Acute care follow-up (pharmacy, labs, nurse practitioner, etc.)

Healthcare Professionals

- Invite case managers from all facilities possibly have quarterly meetings with them
- Meet with Case Managers at hospitals
- Matching providers by insurance type
- Guidelines help provider decide when to refer to new services
- Health / network fair event for hospital care coordinators (host per hospital?)
- Educate hospital frontline staff
- Parkwest checklists for referrals
- Education for professionals

Information Gathering

- Blount Memorial Hospital look at care transitions program -Dr. James program
- Create list of current transitional programs (include criteria, usage, etc.)
- UTMC Heart Failure Clinic within 7 days of discharge
- Affordable Care Act information related to care transitions (TN Healthcare Campaign)

Technology

- Central Site for information (<u>www.tnaaad.org</u>)
- Create central website and outreach through social media.
- Community & professional access to tools in one central location (website)
- etHIN

Other

- Legislation start relationships to share/attain our goals
- Committee idea: Transitional Care Gaps insurance, pharmacy, provider, services
- Need objective data, SMART goals, deliverables
- Triggers for red flags that increase risk of readmission
- Models need to apply across all disciplines
- Connect more with Continuum of Care group (at Ft. Sanders)
- Better use BBBHC listsery to ask questions between members (to gain information)
